# A Message From The President

Well, this past two years has certainly flown by fast enough. A lot of good things have occurred in the neighborhood in that time.

WCNA finally achieved 501-c-3 status as a non-profit after years of work by Jill and past and present officers. This allowed us to become a Community Housing Development Organization (CHDO) and receive HUD funding through the city to rehab and restore the house at 1134 Nelson, saving it from demolition and taking it from decrepitude to being a jewel on the block.

After years of pleading, the city used CEDIT money through our councilmen to restore the 700 block of Wilt Street's brick pavers, with the rest of Wilt promised the be repaired in the future. And we are promised, similarly, a renovation of most of the Broadway streetscape, north of the railroad elevation, this coming year.

Also after years of pleading, the Parks Department, with council help, restored the Swinney Park pond. And furthermore, they are restoring the Thieme Drive overlook at Main Street.

According to the West Central Neighborhood Plan, improvement of the Broadway Corridor buildings was encouraged. This was recently helped along by the granting of Historic District status for buildings in the 1000 and 1100 blocks of Broadway, and by the restoration of the old Firehouse by the Firefighter's Union.


Besides these specifics, we've worked with the city on Harrison Square items and flood topics. We've helped close drug houses and successfully prosecute four arsonists. We've worked with St. Joe Hospital, Fort Wayne Newspapers, Starbucks and ARCH on their improvements. We've put on two more successful House Tours, picked up dead tires, and planted trees. All in all, I think that I've described a highly active and successful neighborhood association.

We should thank many folks for these accomplishments: the officers and board member of the past two years, as well as previous officers who initiated certain of these things; also the folks who've cleaned up, picked up, opened up, patrolled, and restored; add to this those who have attended Association meetings, Board meetings, committee meetings, City meetings, and other miscellaneous meetings. And especially our staff person Jill Downs, who has been an extraordinary trooper in helping to get so much of this done. Jill will be leaving our regular employment at the end of the year and I wish her the best in future endeavors. She has promised to keep in touch.

It's been satisfying, overall. Best of luck to the incoming officers. See you at the next meeting.






## **Tips for Saving Energy**

starting with the easiest and/or most inexpensive things to do

- Make sure heat registers are not blocked by furniture or carpeting
- 2. Turn your thermostat down to between 67°F and 55°F overnight or when you are away for periods of time such as at work or away on vacation
- 3. Turn the thermostat on your water heater down to 125°F
- 4. Wash clothes in cold water
- 5. Take showers instead of baths
- 6. Turn off lights when not in use
- 7. Use fluorescent lighting
- When you are in the market for new appliances, buy energy-efficient models
- Regularly change or clean furnace filters
- Insulate hot water pipes and heating ducts in unheated basements
- 11. Install an insulating blanket around your water heater
- 12. Install low-flow shower heads
- 13. Insulate walls, attics, crawlspaces, and basements
- 14. Close or seal cracks and openings to the exterior or unheated spaces *particularly* in basements and attics This includes: attic access doors, basement windows, dryer vents, pipes, wiring, recessed lights and fans, fireplace dampers etc.
- 15. Install storm windows if none are present
- 16. Install a high-efficiency, 90% or better, furnace

# **Charming Home For Sale**

The WCNA has completed the rehabilitation of the home at 1134 Nelson Street. Located at the end of an historic brick street, this charming gable-front home overlooking Moody Park was rescued from the brink of demolition. Through the assistance of the Indiana Association for Community Economic Development and the City of Fort Wayne, the WCNA financed the renovation of this home using a combination of federal funds and a loan from Tower Bank. It is for sale for \$75,000 to a low-to-moderate income buyer who will be an owner-occupant.

Having suffered years of neglect, much work went into this home to return it to a livable condition. The overall project included the removal of asphalt shingle siding and restoration of the wooden clapboards below, the addition of two dormers to increase headroom in the second story, first floor laundry facilities, new kitchen and half-bath, and the creation of a modern interior layout to include a full bath on the second floor. The house also features new windows, and new mechanical systems including heating and air-conditioning, plumbing, and electrical. The large lot allows for plenty of off-street parking space and room for a garage.

The home is for sale to an owner-occupant who makes no more than 80% of the Area Median Income as required by U.S. Department of Housing and Urban Development. This amounts to \$34,350 for a single person, \$39,250 for a family of two, or \$44,150 for a family of three.





#### **Guidelines for Local Historic Districts**

In 1984, guidelines to be followed in the preservation of local historic districts were adopted by a city ordinance. The guidelines, published by the City of Fort Wayne in <u>Preservation Guidelines for Historic Districts</u>, are meant to serve as a means of directing the aesthetics changes that can be expected to occur in local historic district areas. Anyone residing within the West Central Local Historic District\_must follow the guidelines when making any *exterior* changes to their property. The guidelines include information relating to such things as paint color, windows, doors, siding, landscaping, roofing materials, and other subjects. Copies of the guidelines are also available from the City of Fort Wayne Historic Preservation Department located on the Eighth floor, Room 800 of the City-County Building, One Main Street, Fort Wayne, Indiana 46802.

#### **Financial Incentives**

In order to foster historic preservation, the federal and Indiana state governments have created financial tools to aid in the financing of rehabilitating an historic structure. Some tools may be combined with others to increase the incentive. Anyone who undertakes a rehabilitation project involving a historic, or potentially historic, structure may qualify. Structures in already designated historic districts automatically qualify as being historic.

#### Thieme Drive Flood Control

Earlier this fall, an engineering company hired by the City of Fort Wayne performed soil-boring tests beside Thieme Drive as a means of studying potential flood control measures along the St. Mary's River. The testing analyzed existing soil conditions as they would relate to the potential construction of a flood wall. It also evaluated the impact of ground water conditions in reference to reported basement flooding. The outcome of the testing was that, due to poor soil conditions along the river bank, the construction of a flood wall would be beyond the City's financial ability to implement, and it was suggested that the issue be referred to the Army Corps of Engineers.

To date, the WCNA has received no further communication from the City of Fort Wayne on this matter.

#### **Concerned Citizens Watch**

The Concerned Citizens Watch is a group that keeps an eye on the neighborhood for suspicious activity and works with the Fort Wayne Police department to help combat crime. We appreciate their vigilance and thank them for their time and efforts to make our neighborhood safer.
