# DESIGN COMPETITION

# New neighborhood entrance feature

## **Objectives**

The mission of the West Central Neighborhood Association (WCNA) is to enhance the environment of the West Central neighborhood by improving the quality of urban life for its residents, business owners, and visitors. WCNA is committed to the preservation of diverse neighborhood assets as well as economic and partnership development.

To this end, we are seeking to replace our existing, decades-old neighborhood entrance sign at the Southeast corner of West Jefferson Boulevard and Garden Street. Your design should incorporate the historic nature of the neighborhood as well as its progressive aspects, ideally merging them in a manner that respects the past and embraces the future.

#### **Guidelines**

- a) The design ideas should innovate, inspire and challenge, but entrants are encouraged to consider the practicalities of realizing their scheme;
- b) WCNA would like to install additional neighborhood markers at other locations in the future, and the winning design will have elements that could be adapted for other sites;
- c) Construction budget is \$5,000 per location;
- d) City sign codes permit up to 50 square feet of signage on a structure up to 8 feet tall, located at least 5 feet away from any street right of way edge. If a location is planned on a street right of way, the City Division of Public Works requires a minimum of 18" clear zone between roadway edge and the structure. Public Works generally adopts City sign code requirements in approving signs placed on City rights of way.
- e) The design should be inexpensive for WCNA to own, operate, and maintain during its life expectancy. The designs should be sufficiently durable to last at least 30 years with little to no additional maintenance.

#### **Proposal Requirements**

Participants must submit:

- a) Official competition entry form, which may be found at <a href="http://www.westcentralneighborhood.org/programs/entrance-design-programs">http://www.westcentralneighborhood.org/programs/entrance-design-programs</a>.
- b) A printed graphic mounted on a 24" x 36" foam core board.

- c) PDF in horizontal A1 format (24" x 36") that clearly illustrates the proposed design, inspiration, sensitivity to context and general construction/fabrication methods and materials. Plan and elevation views should be provided with perspective and/or orthogonal views encouraged.
- d) JPG version of the proposal to be viewed on the website (maximum file size 6mb recommended, 1500px wide maximum).

Participants may submit supplemental media as necessary to convey design intent.

#### **Evaluation Criteria**

Proposals will be evaluated on contextual appropriateness, quality of design, viability, sustainability, budget, and innovative approach. WCNA reserves the right to reject and exclude from award consideration any proposal that, in WCNA's opinion:

- a) does not comply with the subject matter or the requirements laid down herein;
- b) does not meet the minimum standard of quality;
- c) is in poor taste or includes offensive or illegal content;
- d) is submitted by a participant who breaches any of the rules herein.

Proposals will be evaluated by a jury consisting of representatives from fields such as architecture, city planning, landscape architecture, and graphic design, as well as representatives from the neighborhood association.

#### **Awards**

The winning proposal will be awarded \$500. The runner-up proposal will be awarded \$250.

All submittal materials become the property of the West Central Neighborhood Association (WCNA) and its assigns. WCNA reserves the right to develop construction and fabrication plans based on submitted designs.
