Speaker – Jill McDevitt, Executive Director of ARCH

- What is ARCH?
 - Arch is a non-profit organization that focuses on protecting and preserving historically and culturally significant assets and buildings in Allen County and northeast Indiana.
 - ARCH took on their first commercial renovation project last year on Broadway (Canton Laundry)
- Indiana Residential Historic Tax Credit
 - Adjusted gross income tax credit for the rehab of a historic residential property. The tax credit is equal to 20% of the qualified expenditures that the taxpayer makes for the preservation or rehab of the historic property.
 - The qualified expenditures must exceed \$10,000. Any permanent fixtures (floors, walls, windows, siding, etc) are eligible.
 - \circ The property must be 50+ years old and on the state historic register.
 - The property must be owned by the taxpayer and be the taxpayer's primary resident.

- Work must be completed in 2 years and adhere to the Secretary of Interior's Standards for Rehabilitation (view at nps.gov).
- The applicant must own the property for 5 years after the project, and can't make any non-appropriate alterations during that time.
- A portion of an approved credit may be carried forward on the taxpayer's subsequent tax returns for up to 15 years.
- The application is available on the DHPA website (State Form 50743)
 - Establish the property's significance
 - State your plan for preservation or rehabilitation
 - Show proof of completion and submit costs and photos

- Additional residential tax credit: State Form 49567, for homes over 50 years old
